NCACH received \$6M in 2017 for the completion of 2 certification phase (Phase 1 and Phase 2) as part of the Washington State Medicaid Transformation Project. The certification process was to ensure North Central Accountable Community of Health (ACH) was capable of serving as the regional lead entity and single point of performance accountability to the state for transformation projects under the Medicaid Transformation Project. The certification process requires NCACH to provide information to demonstrate compliance with expectations set forth by the state and the Centers for Medicare and Medicaid Services (CMS). Through this process, the state assessed whether NCACH was qualified to fulfill the role as the regional lead and distributed project funding to provide initial support.
